

Clerkship of UPJS MF students in the Academic Year 2024/2025 Study programme: Dental Medicine

1. Students in the study programme *Dental Medicine* can perform a professional clerkship at the L. Pasteur University Hospital in Košice (UNLP) and at the private workplaces.

2. Students in the **2**nd **evidence year** perform the clerkship according to the group schedule during the summer term of the academic year 2024/2025 at the 1st Department of Stomatology, the Department of Stomatology and Maxillofacial Surgery, and at Košice Academy, Bačíkova 7, in two periods:

30.06.2025 - 11.07.2025

14.07.2025 - 25.07.2025

Those students are **not** requested to submit "the Request to take the clerkship in the academic year 2024/2025". The students' enrolment for the clerkship will take place at the Secretary Offices of the Dental Departments by **25.04.2025**, at the latest.

3. Students in the 3rd and 5th evidence year:

a.) wishing to perform the clerkship at **the UNLP Dental Departments** will apply for the clerkship by the form "<u>Request to take the clerkship in the academic year</u>": The scanned copies or hard copies (originals) must be submitted to the study referees by 02.05.2025 at the latest,

b) wishing to perform the clerkship in **a private medical facility in Slovakia**, fill in and print the "Agreement on the provision of professional clerkship "<u>Zmluva o zabezpečení odbornej praxe</u>". The Agreement, confirmed by the private medical facility, is necessary to submit in the form of hard copies or sent electronically to the study referees. After the Agreement is signed by the Dean/Vice-Dean of the Faculty, it is possible to collect personally by the student or receive it electronically back upon to the student's request.

4. Submission of Evaluation of Clerkship:

a. Students performing the professional clerkship at the UNLP workplace submit the "<u>Evaluation</u> <u>of the clerkship</u>" at this workplace where the clerkship is performed.

b. Students performing the professional clerkship out of UNLP are required to submit the hard copies (originals) of the "<u>Evaluation of the clerkship</u>" to Bc. Daniela Popovičová, 1st Department of Stomatology, Trieda SNP, by 31.08.2024, at the latest.

6. Students who do not submit the form <u>Request to take the clerkship in the academic year</u> or Agreement <u>Zmluva o zabezpečení odbornej praxe</u> on the provision of professional clerkship by 02.05.2024 will not be enrolled in the list and will have to complete the clerkship at his/her own expenses.

7. The clinical books are available at the Study Department.

8. Students report themselves on the first day of the clerkship to the secretary office of Dental Departments where the clerkship is performed.
